

## **STUDIO SHED WARRANTY**

## Warranty Policy:

Studio Shed warrants to the original purchaser of the Product that, should there be any defects in the material or workmanship during the initial 12 months (one year) from your receipt of the Product, Studio Shed will either repair or replace the covered defects. [If you are outside of the 12 month (one year) warranty period, use the manufacturer warranty listed below. You can also check with your home owners insurance policy to see if they can assist.]
